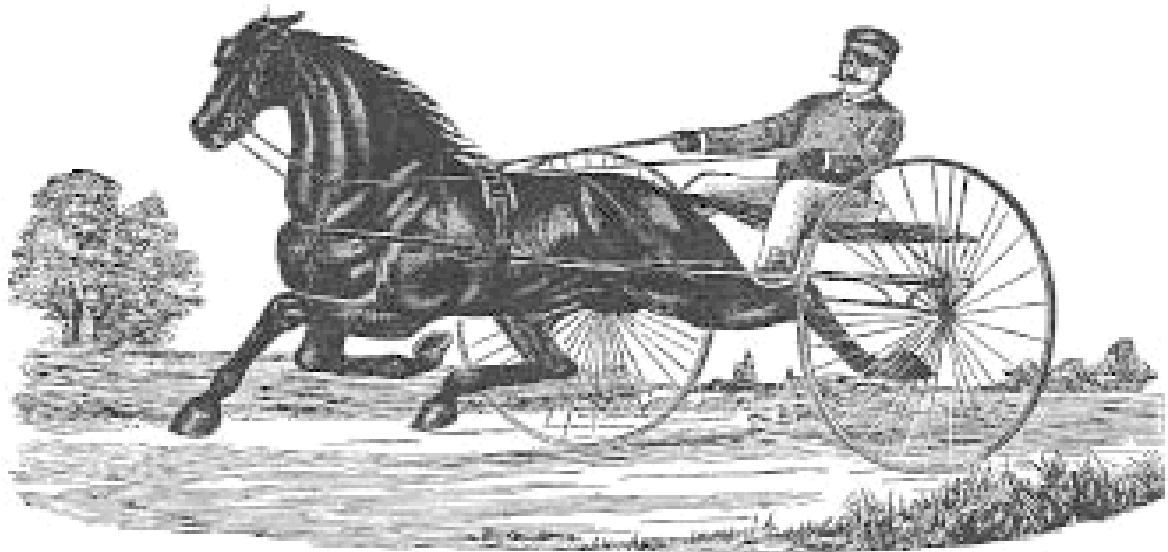

The course will be approximately 5-6 miles of dirt trails and _ mile of tar road. There will be different routes for riders, drivers, and minis. Riders will ride with a partner or group of three. Drivers a navigator is welcome, but not required. Jumps will be optional for riders. The route will cross a bridge (width 10 feet). **Hard Hats are Required** for all participants. A trophy and six ribbons will be awarded for drivers, riders, and for completing both sections with the same horse, whip, and rider. Paid entries **MUST** be received by **September 30, 2009**. A copy of **COGGINS and RABIES are REQUIRED** with entries.
